## A HISTORIC SPANISH COURT ORDER ON CHINA

On 10th February, the National Court of Spain issued Interpol arrest warrants against 5 Chinese leaders including JIANG ZEMIN, HU JINTAO and LI PENG for their questionable role in human rights violations in Tibet. This order was passed after a 9-yr long legal battle in Madrid under the special Spanish law of UNIVERSAL JUSTICE. This law gives Spanish citizens right to investigate human right violations in such countries where authoritarian governments do not permit justice to the victim communities. A similar judgement of the Spanish court in 1998 had lead to the arrest of notorious Chilean dictator General Pinochet in Britain. 10 similar cases, including USA's actions in Guantanamo Bay are currently under review of the Spanish court.

However, instead of taking action on the latest court orders, the Spanish government decided to surrender to Chinese pressure and only a day after the historic court orders its ruling party moved a bill in the Spanish Parliament to drop the law of UNIVERSAL JUSTICE from the constitution of Spain This case has given rise to an international debate on the sincerity and vulnerability of powers like European Union in protecting human rights across the world.

Rev. Lama THUBTEN WANGCHEN is a prime witness and a senior member of the Spanish team which filed this legal petition and won the case. He is also the Director of Casa del Tibet (Tibet House) at Barcelona (Spain). Rev. WANGCHEN will present the background of this historic case to underline how the present Chinese regime is using its economic muscle to bend the international laws to its own convenience.
